






PARTITION OF THE PARTIT

was on standing facing condition which is very near of Gaji Ansary and Nazir Ansary. Suddenly the said trailer started to come back side with very speed and Najir and Gaji have no time to flew away to save their life and in such speed away KEXENDEXTREXT the ENTRY Trailer badly hit Gaji Ansary and his motor cycle, causing severe injuries on his person and motor cycle bearing No.WB-56N-6148 has been badly damaged.

- 2. That Najir Ansary along with other took the injured Gaji Ansari to Purulia Deben Mahato Hospital Purulia for treatment and having critical condition the injured Gaji Ansary shifted to Bokaro general hospital for better treatment were Gaji Ansary treated till 31.12.2021 and on being critical kkkk condition Gaji was shifted to Rajendra Medical Institute Medical Science (RIMS) and admitted on 1.1.2022 but unfortunately Gaji Ansary expired on 02.1.2022.at RIMS.
- 3. That, the accident took place due to rush and negrigent driving of the driver of vehicle No. D-09-6112.
- 4. That the complainant lodged FIR of the above accident to the O.C. Purulia(M) P.S.





The police of Purulia(M) P.s. did not started any case and so, on 17.03.2022 the complainant lodged complain before the S.P.Purulia regarding the above accident but S.P.also, remained mum and so, the complainant is lodging this complain before this court.
