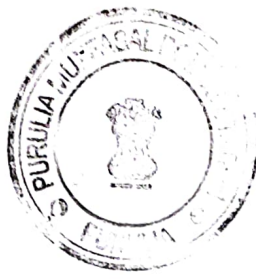

Respected Sir,

In producing herewith the driver namely 1) Khagen Kalindi (25 yrs) S/O Haren Kalindi of Vill- Bhusa, PO- Beldih, & helper 2) Santosh Sahis (27 yrs) S/O Malindra Sahis of Vill- Beldih, both of PS- Arsha, Dist- Purlia & along with seized vehicle (Tractor) Bearing Reg. No. WB55A-4257 attached with loaded Sand Trolley and with Seizure list, Memo of Arrest and Inspection Memo in respect of the above noted persons before you.

The fact brief is that today (25.04.2022) at 09:05 hrs while I along with force 1) C/683 Mansaram Rajak & 2) C/611 Jitendra Nath Pathak both of Purulia (M) PS left the PS for day mobile duty vide Purulia (M) PS CC No 1836/2022 and GDE No 1196 Dt. 25.04.2022 in PS area. During my day mobile duty, I received a tip off at 11:05 hrs that a suspicious tractor loaded with sand was coming from Kansai river side towards Bhatbandh More. Subsequently, I along with force proceeded towards Beldih Bridge to work out the tip off. While I along with force arrived near at Beldih bridge under Tentlo Mouza under Purulia (M) PS and found that 01 (one) tractor was proceeding towards Bhatbandh More along Bhatbandh-Beldi road. I along with force intercepted, the vehicle (Tractor) bearing No. WB55A-4257 attached with Trolley loaded with Sand at 11:35 hrs and I found the vehicle as well as goods as identical as I received prior information. On being asked, the driver and Helper of said vehicle disclosed their name noted in the above. I asked the driver & helper of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the drivers and helper of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked the driver and helper to produce the valid paper but they stated differently in different times. The incoherent statement of the driver and helper purported to be a suspicious to us. It was ascertained that the driver and helper of the tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they have been running a clandestine business. So it is reasoned to belief that They in cahoots with the owner of the vehicle procured the said sand form Kansai River near Beldi bridge under Tentlo Mouza under Purulia (M) PS side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the (tractor) Bearing No WB55A-4257 attached with Trolley loaded with Sand under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver and helper namely 1) Khagen Kalindi (25 yrs) S/O Haren Kalindi of Vill- Bhusa, PO- Beldih, & 2) Santosh Sahis (27 yrs) S/O Malindra Sahis of Vill- Beldih, both of PS- Arsha, Dist- Purlia after informing the ground of their arrest and issued Memo of Arrest and Inspection Memo against them. Thereafter, I brought the seized tractor to Purulia (M) PS compound.

Under the above facts and circumstances kindly take lawful action against the owner and the driver and helper namely 1) Khagen Kalindi (25 yrs) S/O Haren Kalindi of Vill- Bhusa, PO- Beldih, & 2) Santosh Sahis (27 yrs) S/O Malindra Sahis of Vill- Beldih, both of PS- Arsha, Dist- Purlia of the vehicle as they committed offence u/s 379/411/414 of the IPC & 21(I) (4) of Mines and Minerals (R&D) Act-1957.
