Sir,

In producing herewith the accd. person namely Deba Munda (19 Yrs) s/o Lt. Rama Munda of Sarbagan, Ward No- 22, PS- Purulia (T), Dist.- Purulia under proper memo of arrest along with seized articles & related documents. The following seized articles (1) one iron bodied improvised country made one shutter fire arms having butt, Barrel, trigger & firing pin, having a barrel length of 6.3 inch and butt length of 2.5 inch. (2) One live ammunition cartridge having length of 03 inch on which 7Z, 05, OK is engraved upon the percussion cap, I, PSI Suvajit Nandi of Purulia(T) PS received a source information that one person moving suspiciously near Locoshed Para behind Purulia Railway Station under Purulia(T) PS probably with an illegal weapon. I informed I/C Purulia (T) PS regarding the source information and as per his direction myself along with force namely (1) C/586 Bholanath Dey (2) C/2499 Rintu Mondal left for Locoshed Para behind Purulia Railway Station under Purulia(T) PS with force (Vide Purulia(T) PS C.C No- 820/22 dtd 04.04.2022) to work out the source information vide Purulia(T) PS GDE No- 200 dtd 04.04.22.

I along with force reached at the PO and as per identification of my source I along with force stopped the above noted suspected person. I asked his name and address which is noted above. There after disclosing my identity as PSI Suvajit Nandi of Purulia (T) PS I and force offered him to search our body but no local witnesses could be found at that time. He searched our body including the yehicle and the driver but found nothing objectionable article. So I prepared Nil seizure list duly signed by him. After that we started searching him and on searching I recovered the above noted fire arms loaded with one live ammunition from his back side of the waist tucked in the grey blue faded designed jeans pant and tiger printed half Shirt which he was wearing at the time of detention. On asking he failed to produce any valid documents and papers in favour of that fire arms and ammunition. He also failed to give satisfactory answer for carrying this arms and ammunition. I seized the arms & ammunition under proper seizure list which was duly signed by the accused person as well as the police witnesses as no local witnesses were found as mentioned above. I unloaded the live ammunition from the said fire arms and seized the arms and ammunition in between 22:15 hrs to 22:45 hrs under proper seizure list. After the seizure I arrested the accused person observing all legal formalities as laid down by Hon'ble Supreme Court regarding the arrest of Deba Munda which comes under per view of Indian Arms Act. After that I along with force interrogated him but he did not co-operated. I along with force also searched the nearby area under artificial light but we found nothing. After that I along with force and arrested accused person returned to PS.

I therefore pray to kindly start a specific case against the above noted accused person under proper section of law and arrange for proper investigation.
