Sir.

In producing herewith the accd. person namely Akram Ansary (20 Yrs) s/o Hafijul Ansary of Katin Para Near Majhi Bandh, Ward No- 22, PS- Purulia (T), Dist.- Purulia under proper memo of arrest along with seized articles & related documents. The following seized articles (1) one improvised country made fire arms in working condition having butt (4 inch), Barrel (4.9 inch) Body (3.5 inch) with working trigger & hammer. The body and barrel is covered with green paint & the butt is wood coated. (2) One live ammunition of length 2.9 inch on which 8MM KF is engraved. I, SI Supratik Mondal of Purulia(T) PS received a source information that one person moving suspiciously near Tentuleswari Kali Mandir. under Purulia(T) PS with some illegal weapon. I informed I/C Purulia (T) PS regarding the source information and as per his direction myself along with force namely (1) C/2366 Anupam Das (2) C/3191 Tarun Sahoo (3) NVF/479 Nirod Singh Sardar left for Tentuleswari Kali Mandir, near Dulmi Bandh with force (Vide Purulia(T) PS C.C No- 804/22 dtd 02.04.2022) to work out the source information vide Purulia(T) PS GDE No- 106 dtd 02.04.22.

I along with force reached at the PO and as per identification of my source I along with force stopped the above noted suspected person. I asked his name and address which is noted above. There after disclosing my identity as SI Supratik Mondal of Purulia (T) PS I and force offered him to search our body but no local witnesses could be found at that time. He searched our body including the vehicle and the driver. After that we started searching him and on searching I recovered the above noted fire arms loaded with one live ammunition from his waist tucked in the grey colour three quarter pant and white half T-Shirt which he was wearing. On asking he failed to produce any valid documents and papers in favour of that fire arms and ammunition. He also failed to give satisfactory answer for carrying this arms and ammunition. I seized the arms & ammunition under proper seizure list which was duly signed by the accused person as well as the police witnesses as no local witnesses were found as mentioned above. I unloaded the live ammunition from the said fire arms and seized the arms and ammunition in between 21:35 hrs to 22:35 hrs under proper seizure list. After the seizure I arrested the accused person observing all legal formalities as laid down by Hon'ble Supreme Court regarding the arrest of Akram Ansary comes under per view of Indian Arms Act. After that I along with force interrogated him but he did not cooperated. I along with force also searched the nearby area under artificial light but we found nothing. After that I along with force and arrested accused person returned to PS.

I therefore pray to kindly start a specific case against the above noted accused person under proper section of law and arrange for proper investigation.
