Sir, on dated 01.04.2022 my Brother Sri Amit Kumar Singh along with his wife Smt. Suchitra Singh had been coming from Raghunathpur to Anara by Two Wheeler No. WB 56S 3499. Sir, when both were approaching near Rangamati Mobile Tower (Between Sanka Railway Level crossing gate and Rangamati) at about 08.20 P.M then they were collided with the Road vehicle No.NL 01AD 9558 which was standing in zig-zag condition with infringedof main road without follow the instructions of road vehicle act as well as safety precautions around the standing vehicle. Sir,he was neither obstructed back portions through observations with various means nor glowing the back indicators which is the main cause of accident. After heavy accidents both of them by social workers and shifted to Super Speciality Hospital, rescued Raghunathpur, where first aid provided by Doctors and advised to shift immediately for better treatment at higher Central Hospital due to severe injuries. I along with my family member arrived at Mission Hospital Durgapur by two Ambulance for further treatment.
