Sub:- Complaint against Kabul Sen S/o Late Dibakar Sen for rash and negligent driving in drunker condition causing danger to human life.

Sir,

I beg to state that I am Shiba Prasad Deogharia S/o Late Kalyani Prasad Deogharia, resident of Village - Chinpina, P.O. + P.S.- Raghunathpur, Dist.- Purulia. On 08/04/2022 at about 6:00 P.M. my wife namely Shyama Deogharia along with one Madhabi Deogharia were walking through footpath on left side of the Purulia-Bankura main road. When they reached at a point between Petrol Pump of Mr. Madan Barat and Tribeni Construction Office, then one bike came at a high speed in a rash and negligent manner and dashed my wife by coming in footpath. Due to such dashing my wife sustained fatal head injury and her right leg was fractured heavily. The bike rider after dashing my wife fell down himself. The rider was Kabul Sen who is resident of our neighborhood. He was also in drunken condition. I have seen him to drive in drunken condition on many occasions priors to the incident also. My wife is in Nursing Home at present and she is in a very serious condition of health. Due to her treatment and for the mental trauma a few days delay caused in lodging this complaint. The number of the offending bike in WB 82C 0467 (Hero Splender).

The said Kabul Sen is a habitual drunkard and due to his negligent driving the life of my wife is at stake. I pray for his adequate and exemplenary punishment and to adopt appropriate action to provide my wife with proper justice for her suffering and oblige.
