Sir,


With due respect I PSI Mekdam Sabab of Raghunathpur PS beg to state that I have been detailed for Night Mobile duty along with C/1534 Arup Kundu, C/1068 Ranajit Mandal, C/480 Uttam Bauri vide CC No 1066/22, GDE No 971 dtd 20.04.2022 during the said duty I received telephonic information regarding an accident was taken place on Raghunathpur – Bankura Road (SH-8) near at Beldanga village, then as per direction of IC Raghunathpur PS myself along with force left for work out the said information and reached the spot at about 23:05 hrs. and found that a WAGONR vehicle bearing No. WB 82C/1970 met an accident where the said vehicle collided with a pillar of poultry shop beside the road and nobody was there to rescue the said vehicle, none injured there. Accordingly I started to arrange for recovery of the said accidental damaged vehicle from there. While we recovering the accidental vehicle from the PO after maintaining proper traffic regulation and we are engaging in safe distance from the left side on Santuri – Raghunathpur road (SH-8), In the meantime at about 23:15 hrs suddenly one motorcyclist came from the Sadhu-Saltora side with an excessive speed and hit one of our on duty Constable/1534 Arup Kundu, who was standing on the left side footpath of the road, having full intention for causing death by this act. As a result the said on duty constable received head injuries falling on road and became senseless. All on a sudden we got busy to rescue C/1534 Arup Kundu for shifting him into nearest hospital and left the previous task. Immediately we shifted him to Raghunathpur S.S. Hospital for his treatment by our Police van wherefrom he was referred to higher centre for better management. Now he is admitted at Health World, Durgapur in critical condition. The said motorcyclist left his motorcycle bearing No. WB 38AC/4627 and manage to escape. On enquiry it could be learnt that the name of the rider is Sam Hansda S/o Budhuray Hansda of Vill.- Tarabari, PS – Santuri, Dist.- Purulia and validity of insurance has been expired. Thereafter I seized the above noted offending motorcycle under proper seizure list duly signed by the witnesses.

At the time of accident the road was fully clear and there was no obstruction or other vehicles on the road also to hide his presence over that motorcycle he did not switch on the head light of that motorcycle. From this act it is clear that he has some previous grudge over the police which will be investigated later and due to this only with the intention to kill the Policemen he dashed with the said constable with high speed and caused the incident.

I therefore pray before you, kindly lodge an FIR against the accused driver namely Sam Hansda S/o Budhuray Hansda of Vill.- Tarabari, PS – Santuri, Dist.- Purulia of motorcycle bearing No. WB 38AC/4627 as per law and arrange for its investigation.
