Sir,

In producing here with the accused person namely Sk Abid Hossain @ Bura (34) S/o Lt. Sk Kashem of Vill+PO: Gadibero PS - Raghunathpur, Dist.- Purulia brought under arrest along with seized articles as per seizure list i.e one improvised country made one shooter pipe gun length about 10 inches having iron butt, body, barrel, trigger, firing pin etc and one round live cartridge as per seizure list, I PSI Mekdam Sabab of Raghunathpur PS do hereby lodged a written complaint against the above noted accused person to the effect that on 03/04/2022 ,at 20.35 hrs. In course of evening mobile duty received a secret source information that one youth namely Sk Abid Hossain @ Bura S/o Lt. Sk Kashem of Vill+PO: Gadibero was loitering aimlessly at Bero village in suspicious manner. After receiving such information informed to I/C Raghunathpur sir while myself along with C/480 Uttam Bouri, C/386 Sibendu Sinha, NVF-1087 Sankar Garai and LC/12 Rupu Sarder was out of station for performing evening mobile duty at PS area vide CC no 698/22 dated 03/04/2022 and as per direction of IC Raghunathpur PS, myself along with force rushed to the spot to work out the information. At 21:05 hrs on the same day we reached at Bero Masjid Para more and found that one person was standing near Bero Masjid more and we apprehended him who was carrying one shopping bag as identified by source. On being suspicion I search the apprehended person and found that one improvised country made one shooter pipe gun was wrapped in a plastic carry bag in his shopping bag. On demand on papers the apprehended person failed to produce any valid papers/documents in support of carrying/possessioning such fire arms. On interrogation he disclosed his identity as noted above and he stated that he wanted to sale the same at Raghunathpur area. So after observing all the formalities I seized the fire arms and cartridge in between 21:15 hrs and 21:30 hrs under a proper seizure list in presence of witnesses as well as accused person and make over one copy of the seizure list to him and he put his signature as token of acknowledgement and also properly labelled by me. I searched for the public witnesses but none turned up to give witness. Hence I arrested him, issuing memo of arrest.

I therefore pray that a specific case may kindly be started against the accused person namely Sk Abid Hossain @ Bura (34) S/o Lt. Sk Kashem of Vill+PO: Gadibero PS — Raghunathpur, Dist.- Purulia under proper section of law and arrange its regular investigation.
