Sir,

In producing here with 01(One) Truck bearing registration No. WB55A/1062 loaded with approx 09 (Nine) MT steam coal under proper seizure. I beg to submit that today i.e on 21/04/2022 at 10:35 hrs received a credible source information about illegal coal transportation from Dandua side. Accordingly I informed the matter to IC Santaldih PS and as per his direction I along with ASI Rabin Mukherjee and force of Santaldih Investigation Center vide Santaldih Investigation Center C.C No. 221/22 dated- 21.04.2022 and Santaldih Investigation Center GDE No. 262 dated 21.04.2022 went out for executing the credible source information about illegal transportation of coal. At about 11:15 hrs when we reached at Bogra Bypass near Hanuman Mandir found that the above noted truck is going from Chakbad to Paharigora side. We chased the truck but seeing the Police party from a distance the driver stopped the vehicle and fled away from the spot leaving behind the truck. We chased him but could not able to intercept him. Then we searched the truck and found that the truck is loaded with steam coal. We searched for any valid documents in respect of the said truck as well as coal loaded in it but could not find any valid documents. After finding no other alternative I seized the truck bearing Regd. No. WB55A/1062 loaded with approx 09(Nine) MT steam coal in between 11:55 hrs to 12:15 hrs. under proper seizure list in presence of witnesses duly signed by them. No public witness was available there because the place is a non residential lonely area and scorching heat of the season. After that we arrange for transporting the truck from the PO and send to weigh bridge to weigh the actual quantity of coal. After that we brought the seized coal loaded truck at Santaldih PS and kept the truck at PS compound. Informed IC Santaldih PS and Malkhana officer. I have also seized 1 KG coal from the said seized coal loaded truck as sample.

On secret enquiry through my reliable source it came to light that the owner and driver of the above noted truck with their full knowledge and consent running this clandestine business by means of illegal transportation of coal for their wrongful gain.

Hence I do here by lodge this complaint with a prayer that a specific case may be started against the owner and driver of the truck bearing registration no. WB55A/1062 loaded with approx 09 (Nine) MT steam coal under proper section of law and arrange for its investigation.
