Sub: Request for lodging F.I.R. against arrested accused person Rajib Bouri (35Y), S/O Amrit Bouri of Vill. - Bogra, PS - Santaldih, Dist. - Purulia.

Sir,

In producing herewith arrested accused person namely Rajib Bouri (35Y), S/O Amrit Bouri of Vill. - Bogra, PS - Santaldih, Dist. - Purulia along with seized one Mahindra (Bhoomiputra) tractor bearing reg. No. WB55B4135. I beg to report that today I, SI Subrata Sadhu along with 1) C/1221 Yudhistir Kumar, 2) C/1332 Dilip Kr. Baskey all of Santaldih PS were performing special mobile duty at Singh Basti more under Santaldih PS area vide Santaldih PS C.C No- 1159 dtd 26.04.2022 and GDE No- 1212 dtd. 26.04.2022. At about 18.15 hrs, I found at Singh Basti more one Mahindra (Bhoomiputra) tractor bearing reg. No. WB55B4135 coming from Paharigora side rashly and negligently. We tried to stop him but the driver of the said tractor named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

So, I arrested him as he violated sec 279 IPC. I also seized the vehicle with proper seizure list in presence of witnesses. The whole process of seizure was completed in between 18.35 hrs to 18.55 hrs. His friend was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC may kindly be initiated against Rajib Bouri (35Y), S/O Amrit Bouri of Vill. - Bogra, PS - Santaldih, Dist. - Purulia.
