Sub: Prayer for initiating a cognizable case.

Respected Sir,

In producing herewith one arrested accused person namely Basanta Nunia (38) S/O- Lt. Raju Nunia of Chinakuri Chhai Dhowra 04 No, PS-Kulti, Dist-Paschim Burdwan along with one fire arms and one round of ammunition (Seizure list enclosed). I do hereby lodge a complaint against the above noted arrested accused to the effect that today (04.04.2022) at about 21:05 hrs during my mobile duty reached at near Balitora bridge along with C/1333 Dilip Kr. Mahato and C/1452 Sadhan Ch. Kar vide Santuri PS GDE No- 131 Date: 04.04.2022 & CC No-1026/22 Dt. 04.04.2022, we found that the above noted accused person was moving suspiciously there. On being asked about his suspicious movement he tried to flee away from there. However we managed to apprehend him, searched him and found one iron made local pistol with wooden butt improvised fire arms (length approx 17 cm) loaded with 01 round of 8 MM live ammunition from his exclusive possession which was kept conceal at his right side of waist. Being asked to produce any valid document in support to possess the arms and ammunition, he failed to produce any valid documents for his possession or give any satisfactory answers. I unloaded the ammunition from fire arms and seized the arms and ammunition after preparing proper seizure list duly signed by him and witnesses. The arms & ammunition were properly labeled. I arrested the above noted accused person after preparing arrest Memo.

As he violated the provision of Indian Arms Act, hence he is liable for prosecution under the arms act.

So, I pray a cognizable case may kindly be initiated against Basanta Nunia (38) S/O- Lt. Raju Nunia of Chinakuri Chhai Dhowra 04 No, PS-Kulti, Dist-Paschim Burdwan under proper section of law.
