In producing herewith one seized vehicle i.e. Tractor MAHINDRA & MAHINDRA BHUMIPUTRA 275 DI bearing Reg. Number-WB 67A 5330, & having Engine No-RFNH01335 fitted with Trolley loaded with sand. The fact of the case in brief is that on 27/04/20222 I, ASI Madhu Mangal Bauri of Santuri P.S along with force were on mobile duty. During mobile duty 27/4/2022 at about 18:45 hrs received credible source information that one Tractor is coming from Mohanpur Village side under Santuri PS loaded with sand. After receiving this information we were proceeding towards Mohanpur Village to work out the information. When we reached near Mohanpur Village, found that one Tractor is coming from Mohanpur Village side loaded with sand (Approx. 100 cft). On seeing the Police party the driver was trying to flee away. Number-WB 67A 5330, & having Engine No- RFNH01335 fitted with Trolley with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of Tractor MAHINDRA & MAHINDRA BHUMIPUTRA 275 DI bearing Reg. Number-WB 67A 5330, & having Engine No- RFNH01335 fitted with Trolley may kindly be started and arrange for its investigation.
