Sir,

In producing herewith the accd. person namely Jagannath Mukharjee (30 Yrs) s/o- Satyanarayan Mukharjee of Vill + P.O- Satra, P.S- Arsha, Dist- Purulia under proper memo of arrest along with related documents. The following seized articles (i) One improvised country made iron made fire arms (having barrel, butt, trigger and firing pin) having Total Length- 10 inch approx., Calibre- .303", (ii) One .303" live cartridge ammunition of length 3 inch (approx.) and (iii) one Toto bearing Registration No- WB55B/2655. In course of my anti-crime PS mobile duty I, PSI Surajit Kr. Das of Tamna PS received a source information at about 22:05 hrs that one person namely Jagannath Mukharjee (30 Yrs) s/o- Satyanarayan Mukharjee of Vill + P.O- Satra, P.S- Arsha, Dist- Purulia moving suspiciously near Koradih Oil Mill under Tamna PS, Dist- Purulia with one Toto bearing Registration No- WB55B/2655. I informed the matter to O/C Tamna PS and as per his direction myself along with force (i) C/138 Bani Bandopadhyay & (ii) NVF/1028 Rajesh Mahato all of Tamna PS left to work out the said source information (vide Tamna PS C.C No- 918/2022 dtd- 02.04.2022 and GDE No- 78 dtd- 02.04.2022).

While myself along with force reached at near Koradih Oil Mill under Tamna PS at about 22:25 hrs, as per identification of my source myself along with force tried to stop the above noted suspected person. But seeing the police party he fled away with his Toto. After a hot chase we able to intercept him near Pond side at Koradih Oil Mill. Then I asked his name and address which is noted above. After that we started searching him but the suspected person refused to search. On searching I recovered the above mentioned fire arms loaded with one live ammunition from his waist. On asking he failed to produce any valid documents and papers in favour of that fire arms and ammunition. He also failed to give satisfactory answer for keeping this arms and ammunition in his possession. So, I seized the said arms & ammunition under proper seizure list which was duly signed by the accused person. After the seizure I arrested the accused person observing all legal formalities as laid down by Hon'ble Supreme Court regarding the arrest of Jagannath Mukharjee (30 Yrs) s/o- Satyanarayan Mukharjee of Vill + P.O- Satra, P.S- Arsha, Dist- Purulia, comes under per view of Indian Arms Act. After that myself along with force with seized articles and arrested accused person returned to PS.

I therefore pray to kindly start a specific case against the above noted accused person under proper section of law and arrange for proper investigation.
