Sir,

In producing herewith the arrested accused persons namely (1) Kuntal Bouri (28 yrs), S/o Magaram Bouri of Vill-Barabagan (2) Kousal Mahammad (35 yrs), S/o Lt. Md. Jalil of Ram Mandir Chagada both of PS-Adra, Dist-Purulia (3) Suraj Kumar Mahato (21 Yrs) S/o Ashok Mahato of Manitar near JKD office, PS-Dhansar, Dist- Dhanbad, A.P.C.O Nandalal Prasad Kurmi of Traffic Colony near Ganesh pandal Adra, PS-Adra, Dist-Purulia and (4) Owner of the shop and brought under seizure (i) 01 (One) no Lenovo Black Color Monitor, Model No-A15 and S.L. No-PB82C44 (ii) 01 (one) no Zebronics Black color keyboard (iii) 01 (one) no Zebronics Black Color Mouse, (iv) 01(One) Citizen Black color Printer (v) Cash of Rs 1120 - (One thousands one hundred twenty rupees only) under proper seizure duly signed by the witnesses as well as accused persons. I ASI Tanmoy Chatterjee of Adra PS do hereby lodged complaint against above noted arrested accused persons to the effect that today (04.05.2022) at 19:05 hrs during evening mobile duty vide Adra PS GDE No. 154 dated 04.05.2022 received information from my reliable source that an online illegal gambling in the form of LOTO Lottery is going in a room situated at Sevanagar under PS Adra. Accordingly I informed the matter to IC Adra PS and as per his kind direction myself along with my accompanying C/1119 Susanta Kr Sinha, C/2846 Sankhujit Singha Mahapatra, CD156 Deb Dulal Majhi vide Adra PS CC No-1593/22 dtd.04.05.22 left for Sevanagar to work out the information.

At about 19:35 hrs we reached at Sevanagar and as indicated by my source we entered into the room and found that the above noted accused persons are operating online LOTO Lottery to some persons present there in lieu of money. Seeing the police persons the customers, those who were present there left the shop premises and fled away however we could managed to detain above noted accused persons. On search Cash of Rs 1120 - (One thousands one hundred twenty rupees only) was found on the table in front of said accused persons. On being asked said detained persons disclosed their identities as noted above. On search apart from the cash the above noted articles (SI. No-i to SI. No v) found present in that room in working condition and being used for the purpose of running such lottery. On demand they failed to produce any license or documents entrusted to them by any Govt. authority for running such online LOTO Lottery. On prolonged interrogation they admitted their guilt that they are running such online legal gambling in the form of LOTO Lottery to the common people in lieu of money for the wrongful gain and wrongful loss, also causing huge loss of Govt. revenue. The money Rs 1120 - (One thousands one hundred twenty rupees only) of their table is the sale proceed of said online LOTO lottery for today up till now. So I seized the above articles including cash from the possession of said detained accused persons duly signed by the accompanying Police forces. As the above noted accused persons committed an offence which is punishable u/s - 3/4 of WBG & PC Act I arrested them after observing all formalities of arrest. The Search, seizure and arrest completed in between 19:45 hrs and 20:45 hrs.

Under the above fact and circumstances I pray that a case under section 3/4 of WBG & PC Act may kindly started against accused (1) Kuntal Bouri (28 yrs), S/o Magaram Bouri of Vill-Barabagan (2) Kousal Mahammad (35 yrs), S/o Lt. Md. Jalil of Ram Mandir (3) Suraj Kumar Mahato (21 Yrs) S/o Ashok Mahato of Manitar near JKD office, PS-Dhansar, Dist- Dhanbad, A.P.C.O Nandalal Prasad Kurmi of Traffic Colony near Ganesh pandal Adra and (4) Owner of the shop u/s - 3/4 of W.B.G & PC Act and arrange for its investigation.
