In producing herewith 03 (Three) accused persons namely 1) Siru Malakar (20 Yrs), S/O-Lt. Suraj Malakar of Vill-Panchudanga 2) Mrinal Kotka (20 yrs), S/O-Lt. Dhiren Kotka of Panchudanga Aam Talab, Nawa Patty 3) Sachine Sahis (22 Yrs) S/O Tinku Sahis of Panchudanga Bhoot Bunglow, all of PS-Adra, Dist-Purulia along with seized articles such as 1. One Iron Bhojali having wooden butt length approx 14.04 inch, 2. One Iron rod which is one side arrowheaded length approx 2½.ft. 3. One Bamboo Stick length approx 4 feet, 4. One red colour small charger torch as per seizure list.

I SI Madan Chandra Supakar do hereby submit that on 21.05.2022 at 00:55 hrs I/C Adra PS received source information that 05-06 persons were assembled at "Aam Talab of Panchudanga village" and they were whispering about committing Dacoity in nearby Arrah Village with deadly weapon. As per order I/C Adra PS 1 along with forces namely 1) C/ 37 Durjan Murmu 2) C/571 Hashib Khan both of Adra PS vide C.C. No-1705/22, Dated- 20.05.2022 left for Aam Talab of Panchudanga village to work out the said information.


I along with force reached at "Aam Talab of Panchudanga village at 01:15 hrs by keeping the police vehicle at a distance of 200 meters away (approx) then we approached to the "Aam Talab" at an open space. We heard suspicious human voices at a distance from 25-30 meters to talking among themselves. I also found 05-06 persons were assembled there and after having heard and seen this I along with forces confronted suspicious character as police party and they tried to flee away from the spot but we able to apprehend above noted 03 persons. On being asked they disclosed their identity as noted above. Rest 02-03 persons fled away from the spot due to the darkness as well as geography of the locality. Then I offered the detained persons to search me and my Police party before searching their body, but they refused. After that we searched them. During search found 1. One Iron Bhojali having wooden butt length approx 14.04 inch recovered in his west back side in concealed by full pant and shirt of Siru Malakar. 2. One Iron rod which is one side arrowheaded length approx 2½.ft recovered from the possession of Mrinal Kotka, 3. One Bamboo Stick length approx 4 feet and one red colour small charger torch from the possession of Sachine Sahis. On interrogation the accused persons disclosed their names and address as noted above and confessed that they were assembled there for committing Dacoity at Arrah village during this night. So, I arrested them informing the ground of arrest, observing all arresting guidelines and seized the above noted articles and labeled duly signed by the police witnesses as there were no local witnesses available. As it was evident during our raid the accused persons assembled at a solitary place and were preparing amongst themselves with weapons found in their possessions for committing Dacoity at Arrah village, actually committed an offence punishable U/S- 399/402 IPC. In view of this I arrested the above noted 03 (Three) accused persons and seized the weapons from their possession by preparing seizure list on the spot duly signed by the accused persons as well as police party and brought them to P.S.

Hence I pray a specific case may kindly be started against 1) Siru Malakar (20 Yrs), S/O-Lt. Suraj Malakar of Vill-Panchudanga 2) Mrinal Kotka (20 yrs), S/O-Lt. Dhiren Kotka of Panchudanga Aam Talab, Nawa Patty 3) Sachine Sahis (22 Yrs) S/O Tinku Sahis of Panchudanga Bhoot Bunglow all of PS-Adra, Dist-Purulia & other 02/03 unknown miscreants under proper section of law and arrange its investigation.
