
I beg to report that today (30.04.22) myself along with (i) C/238 Dipak Bagti of Arsha PS (ii) C/1002 Arif Mohammad and (iii) C/1015 Ritwik Kar both of SAP 7th BN camp at Arsha PS were performing Spl. Naka checking duty at Palpal Morh under Arsha PS area vide Arsha PS Spl. C.C No- 215/22 dtd. 30.04.22 and Arsha PS GDE No- 1250 dtd- 30.04.22 at about 15.15 hrs, I found one motor Cycle bearing Registration No- WB56N/6658 coming from Begunkodar side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may causing endanger to human life. So, I arrested him as he violated Sec. 279 IPC and I also seized the motor cycle in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore I pray that a specific case may kindly be start against accused Debdut Gorai (24Yrs) S/o-Chutu Gorai of Torang, PS- Arsha, Dist- Purulia.


