Sir,
In producing here with one arrested accused person namely Tunaram Mahato (40 yrs) S/O
Lt. Maliram Mahato of vill Mankiary, P.S.-Arsha Dist-Purulia along with following seized articles.

One white colour plastic container with approx 25 ltrs. of ID liquor.
 (Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, SI Subal Goswami of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 03.05.2022 at about 22.15 hrs. during my Spl. raid duty at PS area, receive source information over telephone that the above noted occused has been selling ID liquor in his house. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with C/- 853 Kiran Ch. Murmu of Arsha PS and C/- 351 Pratik Karmakar of SAP 7th BN camp at Arsha PS rushed in the house of Tunaram Mahato (40 yrs) S/O Lt. Maliram Mahato of vill Mankiary, P.S.-Arsha Dist-Purulia to work out the information vide Arsha PS C.C. No. 920/22 dtd. 03.05.2022 and GDE No. 108 Dtd. 03.05.2022 Reaching at his house at about 22.35 hrs we fixed-up in the house of above noted accd. person and found that selling of Id Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehended the above noted accused person. On demand of showing papers he failed to produce any valid documents in support of selling ID liquor. So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly scaled and labeled duly signed by the accused person and witnesses among which approx 500 ml taken out from the above container as sample packed with sealing wax with label. During interrogation he confessed his guilt. So, I arrested him after observing all the formalities issuing memo of arrest as he was selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused person namely Tunaram Mahato (40 yrs) S/O Lt. Maliram Mahato of vill Mankiary, P.S.-Arsha Dist-Purulia under proper section of law.
