Sub: Request for lodging F.I.R. against arrested accused person Rajib Murmu (21Yrs) S/o-Khetu Murmu of Chhatni, PS- Bagmundi, Dist- Purulia.

Sir,

In producing herewith arrested accused person namely Rajib Murmu (21Yrs) S/o-Khetu Murmu of Chhatni, PS- Bagmundi, Dist- Purulia along with one seized Red Colour Yamaha R-15 bearing Registration No-JH01CJ/9548.

I beg to report that today (10.05.22) myself along with (i) C/109 Surjatapa Dolai (ii) C/146 Maheswar Singh Sardar and (iii) C/222 Pravash Ch. Mandal all of Arsha PS were performing Naka checking duty at Aharra Morh under Arsha PS area vide Arsha PS C.C No- 963/22 dtd. 10.05.22 and Arsha PS GDE No- 361 dtd- 30.04.22 at about 16.05 hrs, I found one motor Cycle bearing Registration No- JH01CJ/9548 driving by Rajib Murmu (21Yrs) S/o-Khetu Murmu of Chhatni, PS- Bagmundi, Dist- Purulia without helmet coming from Tamna side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as Rajib Murmu (21Yrs) S/o-Khetu Murmu of Chhatni, PS- Bagmundi, Dist- Purulia, but unable to give any satisfactory account for his such rush and negligent driving and not wearing helmet which may causing endanger to him and others. So, I arrested him as he violated Sec. 279 IPC & 194D M.V Act and I also seized the motor cycle in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore I pray that a specific case may kindly be start against accused Rajib Murmu (21Yrs) S/o-Khetu Murmu of Chhatni, PS- Bagmundi, Dist- Purulia.
