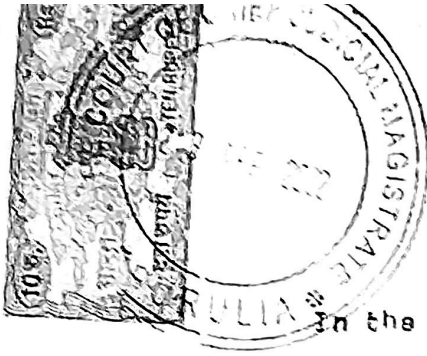

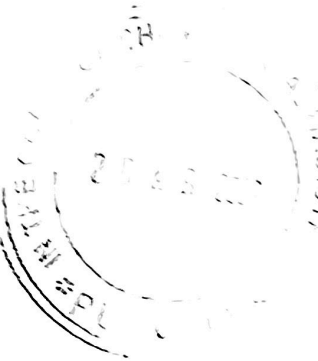

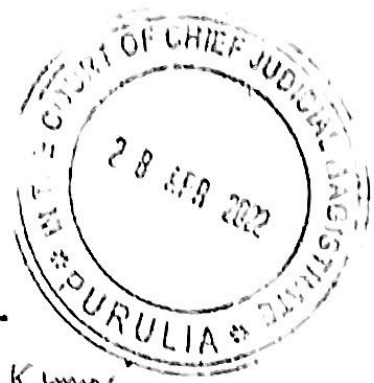

- 2nd That Bhikhakar Kumar (Since deceased) the father in-law of the Complainant had lands at Mouza Misirdih, bearing R. S. Plot No's 979, 980, 974 and 912;
- 3rd That the aforesaid Bhikhakar Kumar by Registered sale deed being No.3599 dated 8.6.1983 sold the Schedule properties measuring 1.32 Acres consisting of 4 R. S. Plots bearing R. S. Plot No's 979, 980, 974 and 912 fully described and mentioned in Schedule below after taking adequate consideration. The Complainant has purchased the property from her stridhan property.
4. That Ganesh Kumar the husband of the Complainant by concealing his status married for the second time with one Basanti Kumar of Village Patuara. The said marital tie of Ganesh Kumar with the Complainant is still in subsistence;
5. That out of wedlock with Basanti Kumar the said

Basanti has been blessed with two child namely Arjun Kumar and Utpal Kumar.

6. That it is pertinent to mention here that Ganesh Kumar, Basanti Kumar, Arjun Kumar and Utpal Kumar were/are fully aware about the sale deed executed by Bhikhakar Kumar in favour of the Complainant and they are also aware about the possession of the Complainant

7. That after marriage with Basanti the said Ganesh Kumar has been residing separately.

8. That the aforesaid Ganesh Kumar @ Ganesh Chandra Kumar illegally and wrongfully in order to deceive and cheat the Complainant has executed a deed of Gift being No.4009 dated 4.9.2021 in favour of Accused Arjun Kumar and Utpal Kumar in respect of the Schedule property and other propert- ties.

9. That the accused persons in concert and connivance with each other and in order to deceive the Complainant have executed the so called deed of gift on 4.9.2021 which was Registered before the Additional District Sub-Registrar Purulia and in the alleged deed, Accused No's 5 and 6 are the witnesses and all those Accused persons had sufficient knowledge regarding the earlier deed executed by Bhikhakar Kumar in favour of the present Complainant.

10. That all those accused persons have formed a league in order to deceive and cheat the complainant.

The alleged deed of gift dated 4.9.2021 is illegal and invalid one and have been so made with a view to injure the interest of the Complainant.

11. That by the aforesaid alleged deed the Complainant has been deceived /cheated at the instance of the accused persons and the Accused persons are also creating pre-mental pressure upon the aged Complainant not to do anything against them.

12. That the Complainant on 7.3.2022 sent a the Petition of Complaint to the Officer-in-charge, Arsha P.S. by Registered Post with Ack-due with a request to take steps. But as Accused Arjun Kumar is a Civic Police attached to Arsha P.S., So no action is being taken.

13. That the Complainant thereafter on 30.3.2022 served a Petition of complaint before the Superintendent of Police, Purulia.

14. That the Accused persons are torturing the Complainant both physically and mentally and are also ~~toxic~~ giving out threats in the locality that they will cause harm to the Complainant and her two daughters.

15. That the accused persons have committed an Offence Under Section 420, I.P.C.

16. That the Complainant is a poor woman and she is not in a position to do the thing in her personal capa-
