Sub: To lodge FIR against owner and driver of one tractor having Reg. No. WB55A/3651 along with trolley (sand approx 60 CFT)

Sir,

In producing herewith, 01(one) tractor having Reg. number. WB55A/3651 along with trolley (loaded with sand approx 60 CFT). Today on 29.05.2022 at about 11.05 hrs. acting on source information, I SI Uttam Kr. Mandal of Arsha PS along with (i) C/-109 Surjatapa Dolai of Arsha PS (ii) C/- 971 Amit Manna and (iii) C/1002 Arif Mohammad both of SAP 7th BN Camp at Arsha PS, Dist-Purulia, left for PS area vide Spl. C.C No. 242 Dtd. 29.05.22. After we reached at Beldih Bridge Ghat under Arsha PS at 12.45 hrs, we conducted raid on the Bank of River Kansai under Arsha PS and found that 01 (one) tractor along with trolley attached with by a hinge was present at Beldih Bridge Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Kansai River, fled away. Police rushed to the tractor and detained the said tractor. Police searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending tractor. Hence, I seized the above noted tractor along with trolley and brought the tractor to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor vide along with the trolley for investigation.
