Sir,

In producing herewith 01 (One) arrested accused person namely Baidyanath Sing Mura (26 Yrs), S/O-Lt-Lakshman Sing Mura of Vill-Rella, PS- Baghmundi, Dist-Purulia along with one seized Mahindra 475 DI tractor along with trolley loaded with sand under proper seizure list , I beg to submit that today on (07.05.2022) I along with (1) C/1445-Bholanath Mistry, (2) C/2287 Nilendu Ghosh of Suisa OP under Baghmundi P.S were performing special mobile duty vide Suisa OP CC No-540/2022, Date-07.05.2022. During my special mobile duty at about 16:45 hrs I along with force reached near Dulmi village under Baghmundi PS and found that a Mahindra Tractor along with trolley loaded with sand was coming from Tunturi side. On seeing the Police party near Dulmi village, the driver of the said tractor was trying to flee away. But after a hot chase, we could able to detain the driver of the said tractor. I asked the driver Baidyanath Sing Mura to produce valid documents in respect of said sand and tractor but he failed to produce any documents regarding lifting & transportation of sand and tractor. I interrogated him thoroughly. During interrogation, he admitted that he is dealing with illegal sand lifting from Subarna-Rekha river. The owner of the said tractor namely Amulya Kumar, S/O-Dharani Kumar of Vill-Marcha, PS- Baghmundi, Dist- Purulia was also involved in this illegal lifting and transportation. Hence, I seized the Mahindra 475 DI tractor vide Reg No-WB55A/7676 along with trolley loaded with sand in between 17.05 hrs to 17.25 hrs under proper seizure list duly signed by him and witnesses and I arrested Baidyanath Sing Mura (26 Yrs), S/O-Lt-Lakshman Sing Mura of Vill-Rella. PS- Baghmundi, Dist-Purulia in between 17.35 hrs. I brought the said sand loaded tractor to Baghmundi P.S compound as such there is every reason to believe that the driver and owner of the vehicle with ill motive dealing with sand illegally without any valid document. So they are liable for offence punishable U/S- 379/411/414/120B/34 IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against namely i) Baidyanath Sing Mura (26 Yrs), S/O-Lt-Lakshman Sing Mura of Vill-Rella, PS- Baghmundi, Dist-Purulia (Driver of the Vehicle), ii) Amulya Kumar, S/O-Dharani Kumar of Vill-Marcha, PS- Baghmundi, Dist- Purulia (Owner of the vehicle) may kindly be started and arrange for its investigation.
