Sir,

In producing herewith 01 (One) arrested accused person namely Brihaspati Kuiry, S/O- Premchand Kuiry of Vill-Lengdih, PS- Baghmundi, Dist-Purulia along with one seized red colour tractor having Reg No-WB55A/3233 along with sand loaded trolley under proper seizure list, I beg to submit that today on (07.05.2022) I along with (1) C/1445-Bholanath Mistry, (2) C/2287 Nilendu Ghosh of Suisa OP under Baghmundi P.S were performing special mobile duty vide Suisa OP CC No-540/2022. Date-07.05.2022. During my special mobile duty at about 18:15 hrs I along with force reached at Tunturi Suisa Road near Lengdih rail gate under Baghmundi PS and found that a Tractor along with trolley loaded with sand was coming from Suisa Side. On seeing the Police party near Lengdih Rail Gate, the driver of the said tractor was trying to flee away. But after a hot chase, we could able to detain the driver of the said tractor. I asked the driver Brihaspati Kuiry to produce valid documents in respect of said sand and tractor but he failed to produce any documents regarding lifting & transportation of sand and tractor. I interrogated him thoroughly. During interrogation, he admitted that he is dealing with illegal sand lifting from Subarna-Rekha river. The owner of the said tractor was also involved in this illegal lifting and transportation. Hence, I seized the tractor vide Reg No- WB55A/3233 along with trolley loaded with sand in between 18:25 hrs to 18.35 hrs under proper seizure list duly signed by him and witnesses and I arrested Brihaspati Kuiry, S/O-Premchand Kuiry of Vill-Lengdih, PS- Baghmundi, Dist-Purulia at 18.45 hrs. I brought the said sand loaded tractor to Baghmundi P.S compound as such there is every reason to believe that the driver and owner of the vehicle with ill motive dealing with sand illegally without any valid document. So they are liable for offence punishable U/S- 379/411/414/120B/34 IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case may kindly be started and arrange for its investigation against the driver namely Brihaspati Kuiry, S/O-Premchand Kuiry of Vill-Lengdih, PS- Baghmundi, Dist-Purulia and owner of the said vehicle.
