On 19/05/2022 at about 12:30 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Baghmundih CCC along with 1. Sri Subhasis Mahato, Sr. O.E., Bagmundi CCC 2. Sajal Kumar Mahanty, Sr. O.E. Bagmundi CCC, entered the premises of Sri Jiten Sahis, S/O- Late Madhu Sahis of Village Madla, P.O.- Madla, PS- Bagmundi, Dist- Purulia and found Sri Jiten Sahis was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.2 KVA. As Sri Jiten Sahis S/O- Late Madhu Sahis committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Subhasis Mahato, Sr. O.E. 2. Sajal Kumar Mahanty, Sr. O.E. . The inspection team left the premises at 12:45 p.m.
