Sir,
In producing here with 03 (Three) arrested accused persons namely (1) Nirmal Mahato (24Y) S/O-Atul Mahato (2) Sambhu Majhi (24Y) S/O-Badal Majhi (3) Bikash Ch. Mahato (23Y) S/O-Satish Ch. Mahato all are of village- Kumir, PS- Kamalpur, Dist- East Singbhum, Jharkhand along with seized motor Cycle under proper seizure list, arrest memos & other relevant papers.

I beg to state that today (18.05.2022), in course of my mobile duty (vide Bandwan PS GDE No- 890, dtd 18.05.2022) I had been to Bandwan Bypass at about 17:55 hrs and found that the three persons including driver with their Motor Cycle (Hero Passion Pro) having number plate-JH-05AZ/8573 were roaming aimlessly near Bandwan Bypass mor by rough and negligence driving with triple riding. Myself along with force signed to stop them but the driver of the Motorcycle drove speedily and disobediently. We could be able to detain them at near Madhupur Model School on Bandwan-Katin road under Bandwan PS area after a hot chasing. This rough and negligence driving would lead to an accident at any time. Being asked the above accused persons could not be able to give any satisfactory answer for that movement on road and public place by such rough driving.

So I arrested them for disobeying the order duly promulgated by public servant, after maintaining all rules of arrest, Issued memo of arrest. I informed them regarding the ground of arrest and arranged for informing their relatives. They were driving the motor cycle on public way in rash and negligently as to endanger to human life. On being asked they did not produce the valid documents in respect of said motor cycle.

So I seized Motor Cycle bearing number plate-JH-05AZ/8573 (Hero Passion Pro) after preparing proper seizure list duly signed by the accused person and witnesses. All the process was done in between 17:55 hrs and 18:45 hrs.

So a specific case may be initiated against them as per law and arrange for its investigation.
