Sir,

In producing here with the seized article 1.একটি কাঠের বাঁটযুক্ত কোদাল 12. দুটি কুরনি 13. দুটা লোহার ধামা 15.একটি শাউল 16. কিছু গাথনির মশলা 17. একটি লোহার হাতুড়ি 1 along with seizure list and lodged a written complainant against one Arun Kundu Modak s/o Lt Amulya Kundu Modak of Barabazar PS Barabazar Dist Purulia to the effect that today as per endorsement of I/C Barabazar PS myself held an enquiry in c/w Barabazar PS GDE No-1003 dt 18/05/22.

l like to note here that today on 18/05/22 ,I was engaged in mobile duty with C/347 Manas Pathak and C/897 Umapada Dhalla vide GDE No-991 dt 18/05/22 and CC No-1339/22 . During the said duty I received an information at about 13.30 hrs from duty officer ASI Partha Sarathi Bose that a construction work is going on at Mouza Barabazar RS Khatian No-200 LR Khatian No-309 LR Plot No- 2012 which is under sub- judice and one TS case vide No- 151/2020 is pending in the court of Civil Judge (Senior Division)Purulia and nest date on 20/06/2022 .

After receiving information myself along with accompanying force rushed to the spot and reached at about 14.05 hrs as shown by source and found that after seen the Police Party some persons fled away as it was day time and we were in uniform, visible from far off. We tried to apprehend them but in vain. We found that construction work is going on there. From that place I seized some articles under proper seizure list which are related to construction work.

Held an enquiry about the matter and so far information collected it is crystal clear that the construction work is going on under the direction of one Arun Kundu Modak s/o Lt Amulya Kundu Modak of Barabazar PS Barabazar Dist Purulia and he violated Ld Court order where TS vide No- 151/2020 which is lying pending.

After returning to PS. I have gone through the PS records and it came to light that in this matter LSI Ranjita Mahato lodged a diary vide GDE No-1774 dt 30/04/22 and after enquiry submitted prosecution u/s 107 Cr.PC against Arun Kundu Modak s/o Lt Amulya Kundu Modak of Barabazar PS Barabazar Dist Purulia vide NCR No-1124/22 dt 03/05/22 and ASI Soumendu Das also lodged a Diary vide No-159 dt 04/05/22.

I returned to PS and typed this letter and submitted before I.C Barabazar PS through duty officer ASI Partha Sarati Bose to start a specific case against Arun Kundu Modak s/o Lt Amulya Kundu Modak of Barabazar PS Barabazar Dist Purulia for violation of order of Ld Court.
