Sub : First Information Report

Today on 19.05.2022 around 11.30 am some unidentified hooligans broke into the office of the undersigned and started to abuse and delivered some slang words against all officers and staffs. They were 50-60 in numbers. They entered my chamber, punched and broke the glass of my table, pulled shirt of mine and our head clerk Sri Durgadas Bauri and threatened us that they would kill us, if necessary, with their ulterior motive. Even they went to OTC room and harassed Revenue officers. They forced Revenue Officers to stop their regular government duties. The mobs assaulted and used the criminal force to deter public servant from discharge of their duties. They physically assaulted me and other staffs.

After that those mob forcefully evacuated the whole office staffs along with me and locked the office. They threatened me if I call police they would kill me. We scared and could not call police at that time. They continued to use slang languages, even they uttered racial abuses against Durgadas Bauri.

The situation was so horrendous that we could not contact police at that time. After that, we managed to call police.

Under this situation we feel insecure to do the regular governmental duties. They can attack us at any time in our office or outside the office.

We need security from your end.
