In producing herewith one seized vehicle i.e Tractor Mahindra Model 415 DI DLX having registration no-WB55A/9431 ,Chasis no-MBNAAAVAPJRJ03231 & Engine no-RJJ4YBA5223 fitted with Trolley (without number plate) loaded with sand (approx 100 cft.). The fact of the case in brief is that on 23.05.2022 I PSI Sk Amanur of Hura P.S along with C/959 Babu Ansary, NVF/899 Haren Machhuwar of Hura PS were on Day mobile duty on Kulgora-Keshargarh road vide Hura PS CC No- 1084 Dtd- 23.05.2022. During mobile duty on 23.05.2022 at about 16.45 hrs received credible source information that the above noted (Tractor) is coming from Keshargarh side loaded with sand. After receiving this information we were proceeding towards "Keshargarh school morh" under Hura P.S. When we reached near "Keshargarh school morh" under Hura P.S, found that the above noted (Tractor) was coming from Keshargarh village side. On seeing the Police party the driver of the said tractor stopped the tractor in a distance at Keshargarh School morh and tried to unload the sand loaded in the said tractor. We rushed to the tractor and the driver then fled away after keeping the tractor near "Keshargarh school morh" at 17:15 hrs. We searched the said tractor and found that the tractor is loaded with sand. I searched for any valid documents in respect of sand loaded in the tractor as well as the valid documents in respect of that tractor but nothing was found. Hence I seized the Tractor Mahindra Model 415 DI DLX having registration no-WB55A/9431chasis no-MBNAAAVAPJRJ03231 & Engine no- RJJ4YBA5223, fitted with Trolley (without number plate) loaded with sand (approx 100 cft.) under proper seizure list in presence of available witnesses duly signed by them in between 17:25 hrs. and 17:45 hrs. Thereafter arranging a driver from my source I brought the said tractor to Hura P.S. As such there is every reason to believe that the driver and owner of the Tractor Mahindra Model 415 DI DLX having registration no-WB55A/9431chasis no-MBNAAAVAPJRJ03231 & Engine no- RJJ4YBA5223, fitted with Trolley (without number plate) with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S-379/411/414 IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of Tractor Mahindra Model 415 DI DLX having registration no-WB55A/9431chasis no-MBNAAAVAPJRJ03231 & Engine no- RJJ4YBA5223, fitted with Trolley (without number plate) may kindly be started and arrange for its investigation.
