Sir,

In producing herewith the arrested 02 (two) accused persons namely (i) Subhash Paramanik (40) S/O Lt. Sahadeb Paramanik and (ii) Samir Gope (40) S/O Lt. Late Lakhikanta Gope both of Vill-Belkuri, PS-Purulia (M), Dist-Purulia along with seized article i.e. one seized Truck bearing Reg. No. WB-55A/8583 loaded with approx 12 MT Steam Coal.

I beg to submit that today (04/05/2022) myself along with RM/1493 Sanjay Suba, RM/1479 Rajib Biswakarma were performing anticrime day mobile duty at Jhalda PS area. This refers to Jhalda PS GDE No. 127/22 dt. 04/05/2022 and C.C. No- 1160/22 date- 04/05/2022. During mobile duty at about 08:45 hrs I received a telephonic information from SDPO Jhalda that he is present in a coal factory styled as R.D. Coke & Carbon situated at Brajapur under Jhalda PS and told that he has detained 01 (one) coal loaded truck having Reg. No. WB-55A/8583 and directed me to attend before him immediately. I informed the matter to you and as per your kind direction I rushed to the spot. On reaching to the spot at 09:25 hrs I found SDPO Jhalda sir with force was present there with the detained truck, noted above along with above noted 02 (two) persons. SDPO Jhalda Sir directed me to search the said truck. As such I immediately searched the said truck in presence of him and his force and found it was loaded approx 12 MT Steam Coal. On asking the driver and the helper of the said truck disclosed their identity as (i) Subhash Paramanik (40) S/O Lt. Sahadeb Paramanik and (ii) Samir Gope (40) S/O Lt. Late Lakhikanta Gope both of Vill- Belkuri, PS-Purulia (M), Dist-Purulia respectively but on asking driver Subhash Paramanik of the said Truck failed to produced any papers in respect of the above noted Truck as well as of the said Coal. They also made incoherent statement in respect of possession coal into their truck. I also searched for the Owner, Manager & Staff of the said factory, but none was available there. So, it is reasonable to believe that the driver as well as the helper in cahoots with the owner of the said truck collected the said coal either by theft or by any fraudulent means from anywhere and store the same in the factory, thereafter transporting the same to run clandestine business for wrongful gains with the help of others. On interrogation the driver and helper of the said truck also confessed their guilt. As such it is every reason to believe that the driver as well as the helper in cahoots with the owner of the said truck No. WB-55A/8583 and others are transporting the coal illegally. Subsequently, as per direct supervision of SDPO Jhalda Sir I seized the said truck loaded with approx 12 (twelve) MT Steam Coal under proper seizure list duly signed by the accused driver and the accused helper in presence of the available witnesses. I searched for the public witness but none was available there at that time in that area. Thereafter, I arrested the accused driver as well the accused helper as noted above after informing them the ground of arrest and observing all formalities and issued Memo of arrest against each duly signed by them and arrived at PS with accused persons and the seized articles.

I therefore pray before you that the accused persons namely (i) Subhash Paramanik (40) S/O Lt. Sahadeb Paramanik and (ii) Samir Gope (40) S/O Lt. Late Lakhikanta Gope both of Vill- Belkuri, PS-Purulia (M), Dist-Purulia and the owner of the track having registration no. WB-55A/8583 committed the offence U/S 379/411/413/414/120B of the IPC, so they can be booked and arrange for its investigation.
