Sir,

I, ASI- Majibur Rahaman along with force returned to PS and brought under seizure of (i) 05 (five) lathi in different size, (ii) 04 (four) number of Bricks bat and do hereby submit a written complaint against Goura Mahato S/O Naru Mahato of Tulin Line Dhar under Jhalda PS, Dist-Purulia with approx 25/30 unknown male and female to the effect that on 04/05-05-2022 at night myself along with C/560 Pravash Mandal, C/481 Bisu Sarkar, JC/1452 Yudhistir Kumar, C/3228 Baddinath Mandi, C/2223 Pradip Chowdhury, LCV/2269 Madhuri Mahato all of Tulin OP under Jhalda PS were performing anticrime night patrolling and special raid duty vide Tulin OP GDE No. 119/22 dt. 04/05/2022 in consonance with Tulin OP C.C. No- 902/22 date- 04/05/2022. During the patrolling duty at about 23:45 hrs I heard that DJ sound boxes were playing in high sound at Tulin Line Dhar under Jhalda PS. I informed the matter to duty officer and he noted it in GDE vide Tulin OP GDE no-124 dtd-04/05/22 and informed IC Jhalda PS and as per order of IC Jhalda PS, Myself along with forces left for Tulin Line Dhar under Jhalda PS to work out the information and at 00.15hrs Myself alongwith force reached at the house of Goura Mahato at Tulin Line Dhar under Jhalda PS and found that 04 (four) big size DJ sound boxes were playing in high sound at the house of Goura Mahato on the occasion of marriage ceremony of his daughter. As per guideline of Honorable Supreme Court, DJ boxes are strictly prohibited on any occasion without any valid permission and they were playing DJ boxes with high sound in an odd hour of night. As such, I asked the person who were playing DJ sound boxes of said sound system to produced valid paper / permission for playing sound boxes in huge sound which create annoyance to, injury to health of public and break down the peace and tranquility on that area. They failed to produce any paper in this aspect. When I try to seized said sound boxes approx 25/30 unknown male and females were confined us and obstructed public servant in discharge of lawful duties. We tried our best to understand them that we are public servant and we came here to perform our duties, but they become more furious and started assaulting us with lathi, bricks bat, kick, fist and blows etc. They assaulted C/2223 Pradip Chowdhury with lathi, kick, fist and blows. As a result, he received severe injuries on his body. We tried to convince them in all possible ways so that they leave C/2223 Pradip Chowdhury but they did not pay any heed. Several times, We request them and push back them to rescue C/2223 Pradip Chowdhury in injured condition. I also seized above noted articles from the PO after preparing proper seizure list duly sign by the witnesses. Medical test of C/2223 Pradip Chowdhury was done at Jhalda BPHC.

Therefore, I do hereby lodge this complaint against above noted aced. persons to start a specific case under proper section of law.
