Sub: To start a specific case.

Sir.

I ASI Ramnath Gorain of Tulin OP under Jhalda PS, Dist-Purulia do hereby lodge a complain after arriving at PS that today 05.05.2022. I along with force was performing special mobile duty at OP area vide Tulin OP GDE No-129 dtd- 05.05.2022 and CC No-904/2022 dtd-05.05.2022 received a telephonic information from duty officer of Tulin OP regarding road blocked at Tulin Laxmi mela more on Purulia-Ranchi road (SH-4A) and the road was obstructed by the villagers of Tulin line dhar over the issue that why Police stop DJ sound box in marriage ceremony. Immediately after receiving the information I along with force rushed to the spot after being instructed by I.C Jhalda PS with Govt. vehicle at about 05.15 hrs. As soon as I arrived at the spot, I found that the road has been blocked by approx 100 villagers of Tulin line dhar with the help of bamboo. After forming un-law full assembly under the leadership of (i) Goura Mahato S/O Naru Mahato of Tulin line dhar, PS-Jhalda, Dist-Purulia. Subsequently I saw some of the villagers under the leadership of Goura Mahato threatened the drivers of the vehicle with dire consequences by lathi if they tried to move the vehicles. The vehicular traffic was totally disrupted and seized along the Purulia-Ranchi road. I talked with the leaders to withdraw the blocked but they paid no heed to my words. Thereafter, I informed the matter to I.C Jhalda PS. Despite of all, I persuaded further and tried to convince the agitators that the road is one of the busy public lines of navigation of this district which should not be blocked but they denied my proposal. I along with force started to disperse them form the road but the road blockers obstructed us adamantly from the discharge of our public functions. Latter SDPO Jhalda Sir arrived at the spot and after the prolonged discussion the mob withdrew the blocked at 11.45 hrs. Thereafter, the vehicular traffic movement became normal after our assiduous act. As the villagers of Tulin line dhar committed offence u/s 143/186/283/506 IPC & 18 W.B Highway act. 1964 under the leadership of supra noted persons, ergo, I submitted complain before your good self to started specific case against them.
