Sir,

In producing herewith one arrested accused person namely Susen Sing Mura (50) S/o Lt. Chandra Sing Mura of Vill- Magha, PS Jhalda, Dist Purulia under arrest along with seized articles as per seizer list i.e. approx 05 (Five) liters of illicitly distilled liquor (Cholai) in a white plastic jaricane from which 500 ml in a plastic bottle taken as sample under proper seizure list with label.

I SI Milon Manna of Tulin OP under Jhalda PS do hereby lodged a written complaint against the above noted accused person to the effect that on 13/05/2022 evening myself along with force JC/1444 Niranjana Mahato and JC/1330 Rabindranath Mahato both of Tulin OP were performing Spl. Raid duty at PS area vide Tulin OP CC No. 964/22 dtd 13.05.22 and received a credible source information that one person is selling illicit distilled liquor illegally at his house at Magha village under Jhalda PS. Myself alongwith force left for Magha village to workout the information. At 19:35 hrs reached at the said house at Magha village under Jhalda PS and found that the above noted accused person was selling illicit distilled liquor (Cholai) illegally. On seeing police he conceal his presence at that house but on search we able to trace out him and also found 05 (Five) Ltrs illicit distilled liquor (Cholai) in a white plastic jaricane which was kept conceal in his house. On being asked he disclosed his identity as noted above. On interrogation, he stated that he was selling illicit distilled liquor (cholai) to local people on that area. On demand he failed to produce any valid documents in respect of selling such illicit liquor (Cholai). So, it is reasonable to believe that he was selling illicit liquor illegally without any valid license. So, I seized 05 (Five) liters of illicitly distilled liquor (Cholai) in a white plastic jaricane from which 500 ml in a plastic bottle taken as sample in between 20:05 hrs to 20:25 hrs after preparing proper seizure list duly sign by witnesses and label it and I arrested said accused person namely Susen Sing Mura (50) S/o Lt. Chandra Sing Mura of Vill- Magha, PS Jhalda, Dist Purulia at 20:35 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Susen Sing Mura (50) S/o Lt. Chandra Sing Mura of Vill- Magha, PS Jhalda, Dist Purulia u/s-46A (c) of the Bengal Excise Act 1909.
