Sir,

I would like to inform you that, as per the instruction of the Govt. a camp was organized for School Uniform Project at Community Hall, Tempo Gali, Ward No: 1, Jhalda Municipality and the fabric supplied by the Govt. & other required accessories were stored thereat, alongwith necessary security arrangement like installation of CCTV Camera, Fire Extinguisher etc. and deputation of Police Personnel from your end, as directed by the Govt.

However, it has been reported by the concerned Staff, that when he reached the Community Hall today on 21/05/2022 at about 10:00 am for work, the lock of the Store Room located at 2nd Floor of the Community Hall was found broken, wires of CCTV Cameras in damaged condition and some items to be stolen from the Store Room, by some unknown miscreants. It may be noted that everything was found to be in order & intact till 19/05/2022, during our routine checking at the Camp.

You are therefore requested to kindly lodge a F.I.R. against the unknown miscreants and to enquire into to the matter in order to maintain the law & order situation within the area and for the security of the Govt. property.
