This is to intimate you that I, Rudranarayan Ghose, son of Jayanta Kumar Ghosh am a permanent resident of VIII & Post- Mosina, P.S.- Jhalda, Dist- Purulia (W.B.). There is a Land with proper boundary wall beside my house which is in my possession since last 25 (twenty five) years without any objection from any person. Now some people of the name of (i) Akhil Mahato, son of Late Rabi Mahato (ii) Bikram Mahato, son of Late Rabi Mahato, (iii) Kalabati Mahato, wife of Late Rabi Mahato of Village- Baraganta (Tetultar), Post- Mahatomara, P.S- Jhalda, Dist- Purulia, (iv) Chandi Mahato, son of Late Jayram Mahato, (v) Gita Mahato wife of Chandi Mahato, of Village & Post- Mosina, P.S.- Jhalda, Dist- Purulia, (vi) Ananta Mahato, son of Late Parshuram Mahato of Village - Guridih, Post- Mahatomara, P.S.- Jhalda, Dist- Purulia, (vii) Ranjit Mahato son of Gour Mahato of Village- Buribir, Post- Tulin, PS- Jhalda, Dist- Purulia and their associates has forcibly demolished the said boundary wall on 05-05-2022 at 06.30 AM. Thereafter, they entered into my Land forcibly and erected wall inside my land in absence of me and encroached it. They threatened to my parents to kill them and used slang languages when they tried to resist them from erecting illegal wall. Both of my parents got sick and suffering from panic attack till now for that incident. As an employee of Kalma Gram Panchayat, I am unable to handle this kind of everyday problem after doing my office duties.

In this very sensitive situation, I have become compelled to request you to take legal needful action against the aforesaid member, so that I can protect and enjoy my land and live there peacefully without any panic created by those people and oblige.
