

Sub: Lodging FIR against Jirulal Mahato (38 yrs) S/o- Late Radhu Mahato of Vill-Jaritard PS-Josepur, Dist-Purulia

Sir.

In producing herewith one arrested accused person namely Jirulal Mahato (38 yrs) \$/o- Late Radhu Mahato of Vill-Jaritard PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizer list i.e. 14 (fourteen) bottles country spirit "DfL KUSH" strength measuring 600 ML each bottles out of which one bottle taken as sample under proper seizure with label.

I SI Prabit Kumar Dey of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today 13-05-2022 at about 00:05 hrs when myself along with Ci-1387 Prabir Kumar Mishra, Ci-842 Angshuman Tewari & HG/-45 Abedin Ansary were performed 2nd night mobile duty vide Joypur PS C.C. No-1983/22 as per my source information I reached at Forest More on Purulia-Ranchi road from the shop of Kanthiram Mahato 5/o-Late Thakurdas Mahato at Forest More under Joypur PS and found that the above noted accused person selling country spirit "DH. KUSH" in the shop. On seeing Police persons, he concealed his presence at that shop, but on searching we able to trace out him and also to found that 14 (fourteen) bottles of country spirit "DIL KHUSH" which was kept conceal in a bag in this shop. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling country spirit to the local people in Forest More after collecting from other side but on demand he failed to produce any valid documents in respect of selling such country sprit. So it is reasonable to believe that he was selling the ld liquor illegally without any documents. So I seized the same under proper scizure list in between 13/05/2022 at 00:15 hrs to 00:35 hrs & label duly signed by him and other available witness after taking 01 bottles of DIL KUSH as sample out of 14 (fourteen) of DIL KHUSH each bottle 600 ML.

During further interrogation he confessed his guilt as such I arrested him today 13/05/2022 at 00:45 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Jirulal Mahato (38 yrs) S/o- Late Radhu Mahato of Vill-Jaritard PS-Joypur, Dist-Purulia, U/S-46A (c) of the Bengal Excise Act 1909.
