Sub: Lodging FIR against Rajib Mahato (32 yrs) S/o- Nilkantha Mahato of Vill-Kanudih Sabanpur PS-Joypur, Dist-Purulia

Sir,

In producing herewith one arrested accused person namely Rajib Mahato (32 yrs) S/o- Nilkantha Mahato of Vill-Kanudih Sabanpur PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizer list i.e. 15 (fifteen) bottles country spirit "DIL KUSH" strength measuring 600 ML. each bottles out of which one bottle taken as sample under proper seizure with label.

I SI Mahadeb Rana of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today 13-05-2022 at about 00:45 hrs when myself along with C/-997 Rajkumar Bauri, C/-1356 Rajib Kundu & C/-2217 Souvik Rana were performed night mobile duty vide Joypur PS C.C. No-1982/22 as per my source information I reached at Vill-Kanudih-Sabanpur in the dwelling house of Rajib Mahato under Joypur PS and found that the above noted accused person selling country spirit "DIL KUSH" in the dwelling house. On seeing Police persons, he concealed his presence at that dwelling, but on searching we able to trace out him and also to found that 15 (fifteen) bottles of country spirit "DIL KHUSH" which was kept conceal in this dwelling house. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling country spirit to the local people in Kanudih-Sabanpur village after collecting from other side but on demand he failed to produce any valid documents in respect of selling such country spirit. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 13/05/2022 at 01:15 hrs to 01:35 hrs & label duly signed by him and other available witness after taking 01 bottles of DIL KUSH as sample out of 15 (fifteen) of DIL KHUSH each bottle 600 ML.

During further interrogation he confessed his guilt as such I arrested him today 13/05/2022 at 01:40 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Rajib Mahato (32 yrs) S/o- Nilkantha Mahato of Vill-Kanudih Sabanpur PS-Joypur, Dist-Purulia, U/S-46A (c) of the Bengal Excise Act 1909.
