Sub: Prayer for starting a specific case against one Arjun Mahato (29 Yrs) S/O- Ruplal Mahato of Vill-Keliadabar PS-Pindrajora, Dist-Bokaro State-Jharkhand (Motor Cycle Rider having Regd. No-JH09AM-1800 Black Colour Hero Splender+).

Respected Sir,

With due respect I SI Nagendra Nath Das, beg to submit before you that on 15/05/2022 at about 13:45 hrs while myself along with C/-857 Chepupal Murmu, C/-1234 Mantulal Mandal were performing Naka Checking duty vide Joypur PS CC No-2007/22 Dated-15/05/2022 at Kathaltard Naka point on Purulia Bokaro Road (NH-32) Village-Kathaltard PS-Joypur Dist-Purulia. I found one Motor Cycle was coming from Purulia side towards Bokaro with **Driving Dangerously & with without helmet**. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle without helmet which may cause any time accident to the road user. After long chase we can able to apprehend him at Kathaltard Naka point. On interrogation he made incoherent statement at different time. He disclosed his identity as Arjun Mahato S/O- Ruplal Mahato of Vill-Keliadabar PS-Pindrajora, Dist-Bokaro State-Jharkhan. On being asked he failed to produce any other valid documents of Motor Cycle. Hence he violated the provision of Section 279 IPC & R/W Section-184/194D MV Act. So I seized the Motor Cycle having Regd. No- JH09AM-1800 Black Colour Hero Splender+ at 13:45 hrs to 14:05 hrs under proper seizure list duly signed by the witnesses and arrested the offending rider namely Arjun Mahato (29 Yrs) S/O- Ruplal Mahato of Vill-Keliadabar PS-Pindrajora, Dist-Bokaro State-Jharkhand at 14:10 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailble hence accused rider namely Arjun Mahato was released on bail.

So I pray specific case may kindly be registered against the accused namely Arjun Mahato (29 Yrs) S/O- Ruplal Mahato of Vill-Keliadabar PS-Pindrajora, Dist-Bokaro State-Jharkhand (Motor Cycle Rider having Regd. No- JH09AM-1800 (Black Colour Hero Splender+) for committing offence U/S-279 IPC & R/W Section-184/194D MV. Act.
