I being the Secretary Sri Sudip Banerjee would like to inform you that on dated 24.05.2022 at about 8.30 AM the terminated staff of the institution namely Birinchi Sahis illegally entered into the institution premises by jumping over the main gate and entered into college premises and damaged one UPS which causing financial loss to Rs. 3200/- of the institution and he entered into my office and used filthy and abusive language to me and assaulted me with fists and blows by which caused pain to my chest and thereafter he with the help of iron rod attempted to commit murder aiming to my head and anyhow in order to save my life tried to resist the assault and I sustain bleeding injury on my hand.

It is pertained to mention have that prior to the incident said terminated staff Birinchi Sahis, S/o Binay Sahis, Address- Baragram, P.O- Baragram, P.S- Joypur, Dist.- Purulia, PIN-723103, tried to cause assault to me (Secretary) and damage to the property of the institution.

I am not able to submit this complain on that day because of my injury. So I submitting this complain today.

In such circumstances, I request you to take legal steps against the aforesaid person according to Law.
