Respected Sir,

In producing herewith arrested accused Sunil Bauri (42 Years) S/O Lt Sakari Bauri of village – Shyampur, PO – Sonaijuri, PS - Kashipur, Dist -Purulia along with seized articles, I beg to report that on 02.05.2022 at 18.15 hrs during my mobile duty received telephonic information that the above noted accd selling liquor at Shyampur village in his house. Accordingly I, SI Pratap Ch Ojha along with C/2180 Rajkumar Chalak and C/1208 Suresh Hembram reached at Shyampur village in his house of the above noted accused at 19.05 hrs and found that one person was selling Liquor in his house. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling liquor in his possession. So the above noted accused has committed an offence u/s - 46(A)(c) B.E. Act 1909 Amended up-to date. During search I found One white colour plastic jarikin loaded with approx 10 (Ten) liters ID liquor (Chullu) out of seized ID liquor 375 ml taken out in a bottle as sample with sealed and labeled. I also seized and labeled the seized articles at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person at 19.35 hrs u/s - 67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with above noted seized articles.

Therefore I pray before you that kindly arrange to start a specific case u/s 46(A)(c) B.E. Act 1909 against arrested accused Sunil Bauri (42 Years) S/O Lt Sakari Bauri of village – Shyampur, PO – Sonaijuri, PS - Kashipur, Dist - Purulia and arrange for its investigation.
