Sir,

In producing herewith arrested accused person Puratan Kisku (47 Years) S/O Tuila Kisku of Dholkata, PS - Hura, Dist - Purulia along with seized article i.e. One 'Hero Honda Splendor Pro' Black Colour Motor Cycle having Registration No WB 56D/1018.

I beg to report that today myself along with C/157 Dipak Bauri and C/117 Arpan Mondal both of Kashipur PS were performing mobile duty at Narayangarh village near Kapista Bridge under Kashipur PS area vide Kashipur PS C.C No - 1213/22 dtd. 04.05.2022 and Kashipur PS GDE No - 117 Dtd 04.05.2022. At about 12.05 hrs, I found one 'Hero Honda Splendor Pro' Black Colour Motor Cycle coming from Kashipur side towards Gourangdih rashly and negligently. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly. there was every possibility of loss / serious injury of nearby public due to his such riding. After a hot chase we could able to stop him at Narayangarh village near Kapista Bridge under Kashipur PS. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On being asked he could not able to produce any valid Driving License as well as valid documents in respect of the said motorcycle.

So, I seized one 'Hero Honda Splendor Pro' Black Colour Motor Cycle having Registration No WB 56D/1018 in between 12.15 hrs to 12.25 hrs. and arrested him at 12.35 hrs as he had committed an offence punishable under sec 279 IPC and 194(D)/181/184/190(2)/196 MV Act 1988 in presence of police party and informed his family members accordingly.

Hence, I pray that a specific case U/S 279 IPC and 194(D)/181/184/190(2)/196 MV Act 1988 may kindly be initiated against accused Sujoy Mahato (23 Years) S/O- Lt. Ananda Mahato of Tilgora, P.O - Kalajhor, PS - Para, Dist - Purulia.
