Sub - Prayer for lodging FIR.

Respected Sir,

In producing herewith arrested accused Raju Chowdhury (36 Years) S/O- Manu Chowdhury of village - Pathuriagora, near Indrabil railway station, PS - Kashipur, Dist - Purulia along with seized articles, I beg to report that on 13.05.22 at 19.05 hrs during my mobile duty received telephonic information that the above noted accd selling liquor at Pathuriagora village in his house. Accordingly I, SI Kalyan Kr. Sakha along with C/2180 Rajkumar Chalak and C/797 Chandi ch. Rajak reached at Pathuriagora village in his house of the above noted accused at 19.35 hrs and found that one person was selling Liquor in his house. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling liquor in his possession. So the above noted accused has committed an offence u/s - 46(A)(c) B.E. Act 1909 Amended up-to date. During search I found One white colour plastic jarikin loaded with approx 10 (Ten) liters ID liquor (Chullu) out of seized ID liquor 375 ml taken out in a bottle as sample with sealed and labeled. I also seized and labeled the seized articles at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person at 20.05 hrs u/s - 67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with above noted seized articles.

Therefore I pray before you that kindly arrange to start a specific case u/s 46(A)(c) B.E. Act 1909 against arrested accused Raju Chowdhury (36 Years) S/O- Manu Chowdhury of Village Pathuriagora, near Indrabil railway station, PS - Kashipur, Dist - Purulia and arrange for its investigation.
