Sub: To lodge FIR against owners and drivers of (i) Mahindra B 275 DI(Red Colour) having Rgd No- WB 81/0354 along with trolley (Without number plate) (ii) Mahindra B 275 DI(Red Colour) having Rgd No- WB 55 B/5192, Engine No RMA2EAN1963 , Chassis No MBNABAEXKMRA05995 along with trolley (Without number plate), (iii) Mahindra B 275 DI(Red Colour) having Rgd No- WB 55B/5647, Engine No RMJ2EAN4161 , Chassis No- MBNABAEXKMRJ08095 along with trolley (without number plate), each trolley loaded with sand.

Sir,
In producing herewith, 03(Three) tractors i.e. (i) Mahindra B 275 DI(Red Colour) having Rgd No- WB 81/0354 along with trolley (Without number plate) (ii) Mahindra B 275 DI(Red Colour) having Rgd No- WB 55 B/5192, Engine No RMA2EAN1963 , Chassis No MBNABAEXKMRA05995 along with trolley (Without number plate), (iii) Mahindra B 275 DI(Red Colour) having Rgd No- WB 55B/5647, Engine No RMJ2EAN4161 , Chassis No- MBNABAEXKMRJ08095 along with trolley (without number plate) each trolley loaded with sand app- 70 cft and (iv) 6 pieces old Iron made "Belcha" and 10(ten) pcs iron made Dhama before you.

The nub of the fact in a nutshell is that today on 30.04.2022 at 22.15 hrs I ASI Sibaram Bauri of Kashipur PS along with (i) C/-793 Prasanta Patra and (ii) C/730 Tapas Mandal both of Kashipur PS, Dist- Purulia, left the PS for performing anti crime night mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 1281 Dtd - 30.04.2022 and C.C No. 1276/22 Dtd. 30.04.2022. During my mobile duty, I received a tip off on 01.05.2022 at 03.45 hrs. that some persons were loading some tractors with sand from the river bed of Darkeswar River near Samsan Ghat Kashipur Rajwar Para under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolley of said three tractors. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolleys) at Darkeswar River, fled away from the spot. We rushed to the Tractor and detained the said tractors. We searched the said tractors and found that the tractors are loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending Tractors. Hence, I seized the above noted tractors along with trolleys loaded with sand and other articles and brought the said seized articles to Kashipur PS. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted seized tractors along with the trolleys for investigation.
