I, SI Joydev Mahato of Kenda PS, Dist- Purulia producing herewith one arrested accused person namely Ananda Mahato (32 yrs), S/o-Lt. I beg to submit that today (02-05-2022) during evening Mobile duty acting of a secret source information myself along with C/631 Tulshidas Satpati, C/346 Shaktipada Rajak and HG- 1923 Banamali Manki all are of Kenda PS conducted raid in the house of accused person Ananda Mahato at about 19.15 hrs and found that he was keeping and selling of ID liquor at his residence to the others.
