In producing herewith arrested accused person namely Balam Mura (20 Yrs) S/o- Lt. Arjun Mura of Vill- Bareria, PS- Bagmundi, Dist- Purulia along with one seized Black Gold colour TVS Motor Cycle bearing Registration No-JH05BL-2202 and Eng. No- CF1AG1451656 & Chassis No- MD625CF10G1A12046.

I beg to report that today myself along with C/631 Tulshidas Satpati, NVF-673 Rabi Sing Sardar and HG- 1923 Banamali Manki all are of Kenda PS were performing Day mobile duty at Kenda Jamtal Morh under Kenda PS area vide Kenda PS C.C No-605/22 dtd. 18.05.2022 and Kenda PS GDE No-562 dtd- 18.02.2022 at about 14:55 hrs, I found one Motor Cycle bearing Registration No-JH05BL-2202 coming from Kenda village side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.


So, I arrested him as he violated Sec. 279 IPC and I also seized the motor cycle in presence of witnesses. His family member was also informed about the ground of arrest.
