
In producing herewith one seized vehicle i.e. one blue colour 439 plus Powertrac Tractors having Registration No. WB55A-7944, Chassis No. T053387896BG & Engine No. E3436138 attached with Trolley without number plate loaded with sand approx. 100 cft. The fact of the case in brief is that on 26/05/2022 I along with C/315 Mir Kurban and C/1345 Jitendra Nath Diasi of Kenda PS were on special raid duty. During raid duty on 26/05/2022 at about 19.35 hrs. when we reached near at Shyamdih village under Kenda PS found that the above noted tractor was coming from Kansai river side under Kenda PS. On seeing the Police party driver of the said tractor stopped his tractor in a distance and he fled away after keeping the tractor near at Shyamdih village. We searched the said tractor and found that the tractor was loaded with sand. We waited there some times and held an enquiry about the said tractor but none turned up and demanded as actual owner of the said tractor or the sand. It is ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So seized the tractor bearing Registration No. WB55A-7944, Chassis No. T053387896BG & Engine No. E3436138 attached with Trolley without number plate loaded with sand approx. 100 cft under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging driver from my source and brought the tractor at Kenda PS. So it reason to belief that driver and owner of the said seized tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and driver of the Tractor having Registration No. WB55A-7944, Chassis No. T053387896BG & Engine No. E3436138 attached with Trolley without number plate loaded with sand approx. 100 cft.
