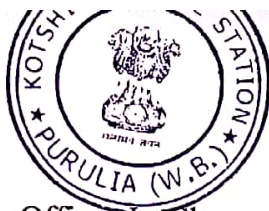

Sir,

In producing herewith 01 (one) arrested accused persons namely Jaymali Kumar (23 yrs) s/o Chutu Kumar of vill.- Dakhin Tatuara, PS- Kotshila, Dist.- Purulia along with seized one tractor bearing registration no. WB-55A/8713 (Chassis No. MBNABAEAKJRF02777, Engine No. RJ2EAN3954) attached with trolley loaded sand under proper seizure list. I beg to submit that today (13/05/2022) I along with (1) C/557 Ambuj Mandal (2) C/1543 Prabir Mandal both of Kotshila P.S were performing Day Mobile duty vide Kotshila PS CC No. 796/22 Date- 13.05.2022. During my mobile duty at about 12.05 hrs I along with force reached at Tatuara Majhidih village under Kotshila PS and found that one red colour tractor bearing registration no. WB-55A/8713, named as 'MAHINDRA -B-275DI' attached with trolley loaded with sand was coming through Tatuara Majhidih village road. On seeing the Police party near Tatuara Majhidih Akhra, the driver of the said tractor was trying to flee away. But after a hot chase, we could able to detain the driver of said tractor. I asked the driver Joymali Kumar to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. During interrogation he confessed that he loaded the tractor with sand by illegal manner for selling the same to make profit by dishonestly for running clandestine business consent with the owner of the said tractor. So, I seized the tractor bearing registration no. WB-55A/8713 (Chassis No. MBNABAEAKJRF02777, Engine No. RJ2EAN3954) attached with trolley under proper seizure list in presence of available witnesses duly signed by them and I arrested the driver namely Jaymali Kumar (23 yrs) s/o Chutu Kumar of vill.- Dakhin Tatuara, PS- Kotshila, Dist.- Purulia. As such there is every reason to believe that the driver and owner of the tractor with ill motive are habitually dealing with sand illegally for selling the same to make profit by dishonestly for running a clandestine business without any valid document. So they are liable for offence punishable U/S 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against namely Jaymali Kumar (23 yrs) s/o Chutu Kumar of vill.- Dakhin Tatuara, PS- Kotshila and the owner of the tractor bearing registration no. WB-55A/8713 (Chassis No. MBNABAEAKJRF02777, Engine No. RJ2EAN3954) may kindly be started and arrange for its investigation.
