I beg to submit that today (20,05,2022) at 05,35 hrs Duty officer ASI Parimal Tewary received a source information to the effect that some person/ persons have kept one leaflet under a plastic bag containing some suspected device of explosive at outside of the gate of Bararola Primary School at Bararola village, under P.S Kotshila during anytime of 19/20-05-22 night to facilitate CPI Maoist movement and urging people to organize anti government movement after making criminal conspiracy. The information was diarized by ASI Parimal Tewary vide Kotshila P.S. G.D.E No. 790 dated-20.05.2022 and accordingly myself along with force of Kotshila PS with Govt. Vehicle No. WB 26C -7292 left for Bararola Primary School to work out the information. At about 05.55 hrs on 20.05.2022 we reached Bararola Primary School and found one leaflet was kept under a plastic bag containing one suspected explosive item in front of the Bararola Primary school gate. Then we cordoned the surrounding area. I passed such information to the superior officers and contacted with Bomb Disposal Squad (BDDS), Purulia through Superiors. Later the team of BDDS, CID, Purulia Unit arrived there at 10.45 hrs and removed the suspected device from that place after maintaining SOP. I then seized the maobadi leaflet from the P.O in presence of available witnesses namely (1) Sanjoy Das and (2) Chutubabu Das in between 11.15 hrs to 11.25 hrs. I took photograph of the leaflet before seizure. Leaflet is written in Bengali script with red ink. The contents of the leaflet-

মুদি সারকার রেলগাড়ি উড়াদিব । পুলিশ দাল নেতাদাল হুসিআ পুলিশ রাসা টেকস সাবধান কোরো । মুদি সারকার । আমরা মারনকে ভয় পাই নাই । মুদি সারকার কেই মার জন্য একোটি টাকা দেয় মরা জন তৈরি আছি কোন মিটিগ মেনিয়ে টুকে জাইদ c.i.p মওবাদি

Then BDDS, CID, Purulia Unit disposed off the suspected explosive device (cylinder shape) at Bararola High School Ground in presence of S.D.P.O, Jhalda and Addl. S.P (Ops), Purulia.

After the disposal by BDDS, CID, Purulia Unit they handed over remnants of suspected device and control earth which were seized by me under proper seizure list were duly signed by my accompanying officer and force as seizure witnesses and duly labeled separately. This is to be noted that since the contents of the leaflet are related to CPI Maoist, no local person came forward to be witness.

From the leaflet and the explosive device it is quite clear the miscreant (s) belong to Maoist group and their action is aimed to frighten common peace loving people and wage war against the state.

After doing all the necessary action I returned to PS at 15:45 hrs today (20.05.2022) with (1) One Maoist Leaflet (2) Remnants of suspected explosive device (3) Two seizure list and started Kotshila P.S Case No-59/2022, Dated-20.05.22, U/S- 121/121A/120B IPC and 04 of The Explosive Substances Act, 1908 against unknown miscreant(s).
