Sir,

In producing here with 02 (two) arrested accused persons namely (1) Bijay Tudu (22 yrs) S/O Late Uday Tudu of Vill- Radhamohonpur, PO-Radhamohonpur (Dhabani), PS-Boro, Dist-Purulia (2) Mahendranath Murmu (18 yrs) S/O Late Sukdeb Murmu of Vill-Nuniya Chatra, PO-Radhamohonpur (Dhabani), PS-Boro, Dist-Purulia along with seized motor Cycle under proper seizure list, arrest memos & other relevant papers.


I beg to state that today (24.05.2022), in course of my mobile duty (vide Manbazar PS GDE No- 912, dtd 24.05.2022) I had been to Manbazar BDO Office more area at about 16:45 hrs and found that the three persons including driver with their Motor Cycle were roaming aimlessly towards Ganesh Sweets more area by rough and negligence driving with triple riding. Myself along with force signed to stop them but the driver of the Motorcycle drove speedily and disobediently. We could be able to detain them at near Ganesh Sweets more under Marbazar PS area after a hot chasing but one person could able to manage the avoid police touch who fled away for police arrest. This rough and negligence driving would lead to an accident at any time. Being asked the above accused persons could not be able to give any satisfactory answer for that movement on road and public place by such rough driving.


So I arrested them for disobeying the order duly promulgated by public servant, after maintaining all rules of arrest, Issued memo of arrest. I informed them regarding the ground of arrest and arranged for informing their relatives. They were driving the motor cycle on public way in rash and negligently as to endanger to human life. On being asked they did not produce the valid documents in respect of said motor cycle.

So I seized motor cycle bearing Reg. No. WB56M/6740 (HF-Delux Hero) after preparing proper seizure list duly signed by the accused persons and witnesses. All the process was done between 17:15 hrs and 17:25 hrs.

So a specific case may be initiated against them as per law and arrange for its investigation.
