Sub:- Complain for starting a specific case .

Sir,

In producing herewith one arrested accused namely Rabidas Murmu (20 years) S/O- Sona Murmu of Vill-Parbelia Kamarkuli ,PS-Neturia ,Dist-Purulia along with one seized Mahindra B275 DI TU MKM DLX tractor having registration No- WB 55B/5864 and Chassis No-MBNABAEXKNRK08168, Engine No- RNK2EAN0062 along with trolley loaded with sand approx 100 Cft. under proper seizure list. I beg to submit that I, SI Abhijit Das along with C/939 Laltu Paul, C/174 Tapandas Bouri and C/159 Dinesh Sardar all are of Neturia PS were performing raid duty vide Neturia PS GD No- 825/22 Dt. 18.05.22 and CC No- 1644/22 date 18.05.2022 and at about 19:45 hrs received a credible source information that one Tractor was coming from Damodar river side towards Parbelia side loaded with sand illegally. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started to move towards Damodar River side at 20:05 hrs we reached at Chinakuri Ghat and found that one tractor is coming from River side and we stopped the vehicle and found that the tractor with trolley having registration number WB 55B/5864 is loaded with sand . I asked the driver to produce valid documents of the vehicle as well as loaded sand but he failed to produce any valid documents or papers of vehicle as well as loaded sand .On being asked he disclosed his identity as Rabidas Murmu (20 years) S/O- Sona Murmu of Vill-Parbelia Kamarkuli ,PS-Neturia ,Dist-Purulia .On preliminary enquiry and his statement it could be learnt that he procured said sand from different illegal area.

So, there is reason to believe that the driver and the registered owner of the vehicle have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Chinakuri Ghat side knowing it to be stolen.

Accordingly, I seized the Tractor having registration number WB 55B/5864 along with trolley, loaded with sand approx 100 C.Ft. under proper seizure list duly signed by him and witnesses and also arrested the driver after preparing arrest memo. In course of arrest I notified him ground of arrest ,issued arrest memo U/S-50 Cr.PC. Brought him PS with seized tractor along with trolley having registration number WB 55B/5864 with loaded sand .So, the driver and the registered owner of the tractor has committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver Rabidas Murmu (20 years) S/O- Sona Murmu of Vill-Parbelia Kamarkuli ,PS-Neturia ,Dist-Purulia and registered owner of the above noted seized tractor U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.
