Sub:- Complain for starting a specific case .

Sir,

In producing herewith two seized tractors (New Holland Plus) having registration No- WB 81/1695 and (Mahindra B275 DI) having registration No- WB 81/0876 along with trolley loaded with sand approx 100 Cft in each tractor under proper seizure list. I beg to submit that I, ASI Bachchu Ghosh along with C/805 Narayan Chandra Dhibar, C/159 Dinesh Sardar all are of Neturia PS were performing evening mobile duty vide Neturia PS GD No- 1219 Dt. 26.05.22 & CC No- 1733/22 date 26.05.2022 and at about 22:05 hrs received a credible source information that two tractors were coming from Deoli village side towards Jhanka side loaded with sand illegally. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started to move towards Jhanka side. At about 22:25 hrs we reached at Jhanka More and found that two tractors are coming from Deoli side and suddenly stopped about 65/70 meter away from us and two persons seems to be the drivers of the tractors got down from the vehicles and started running towards dark side. We chased the persons but in spite of hot chase they managed to flee away. We searched the surrounding area to find out the persons but failed to trace out them. On search we found that the vehicle (Tractor) registration number WB 81/1695 and WB 81/0876 have been loaded with sand approx 100 Cft in each tractors.

So, there is reason to believe that the drivers and registered owners of the vehicle have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Sarbari village side knowing it to be stolen.

Accordingly, I seized the Tractors having registration number WB 81/1695 and WB 81/0876 along with trolley, loaded with sand approx 100 C.Ft in each. under proper seizure list duly signed by witnesses. So, the drivers and registered owners of the tractors have committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against drivers and registered owners of the above noted both seized tractors U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.
