In producing herewith arrested accused person namely Dablu Kr. Yadav (22 Yrs) S/o Rajinder Yadav of Vill- Sangrampur Munger, PS- Sangrampur, Dist- Munger (Bihar) along with seized one Truck (Trailer) bearing Regd. No-JH10BY/3055. I beg to report that today myself along with C/1184 Subhendu Maity, 2) C/1407 Sushanta Goswami and 3) NVF/487 Kirtan Sing Sardar all of Para PS were performing Evening mobile duty by Govt. vehicle heading towards Jhapra more under Para PS area vide Para PS Misc C.C No- 1029 dtd 30.04.2022 and Para PS GDE No- 1129 dtd. 30.04.2022. At about 19.05 hrs, I found at near Jhapra Petrol pump one Truck (Trailer) bearing Regd. No- JH10BY/3055 coming from Purulia side rashly and negligently. We tried to stop him but the driver of the said vehicle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving.
